JACKSON TWP	NO		<p>Political signs may be erected or maintained for a period not to exceed 12 weeks prior to the date the election to which such signs are applicable is scheduled to occur. The same shall be removed within five days following the election. Temporary political signs shall not project higher than 15 feet, as measured from the base of the sign or grade of the nearest adjacent roadway, whichever is higher. The following provisions shall also apply: 1. Public right-of-way. There shall be no limit on the permitted number of temporary political signs displayed. 2. In the public right-of-way no such sign may be located across, over or extending onto the paved portion of any public roadway. Temporary political signs located in a public right-of-way shall be erected or installed in such a manner so as not to interfere with or obstruct access, activity or vision along any public right-of-way. Further, such signs shall not be attached to or placed on traffic signals, utility poles, trees or other similar vegetation.</p>

Election and political campaign signs are permitted on private property with the owner's permission. A maximum of four (4) political signs are permitted on a residential lot and maximum of two (2) are permitted on a non-residential lot. 2. Two (2) signs per candidate are permitted on public property on SR 228. Said signs must be separated by at least two thousand (2000) linear feet. These signs require a permit issued by the Planning Commission accompanied by a One Hundred Dollar (\$100) security deposit. Failure to remove the signs according to this ordinance will result in forfeiture of the security deposit. 3. Election or political campaign signs shall have a maximum area of twelve (12) square feet. Such signs shall be erected no sooner than thirty (30) days prior to the election or political campaign and shall be removed with seven (7) days following the election or conclusion of the political campaign. 4. Election and political Campaign Signs that do not comply with this ordinance shall be removed by the borough at the candidate's expense.
