Commissioner Boozel made the motion to table this item; seconded by Commissioner Geyer. The motion carried unanimously.

2. Lance Welliver opened a single bid received for the Evans City Pool Renovation project from Aqua Pool of East Pittsburgh, PA (see Attachment Book for details). Mr. Welliver requested to table this item for further review, with plans to return to the next public meeting with a recommendation.

Commissioner Boozel made the motion to table this item; seconded by Commissioner Geyer. The motion carried unanimously.

# H. Planning – Economic Development

1. Mark Gordon requested approval of a 14 month Agreement with Delta Development, Inc. with a \$10,000 monthly retainer, plus reasonable and ordinary expenses as provided in Paragraph 4(b)

of agreement and \$67,500 deferred fee upon successful award of BUILD Grant. Mr. Gordon reported this amount will be broken into two payments of \$33,750 each. The agreement will run from July, 2018 through September, 2019, and includes a 30 day termination option.

Commissioner Geyer made the motion; seconded by Commissioner Boozel. Commissioner Boozel asked where the \$140,000 will come from; and Chief Clerk Andrejchak reported it will come from the General Fund. The motion carried unanimously.

2. Mr. Gordon will request approval of agreement with Transloc, Inc. for micro-transit pilot program in the amount of \$19,500.

Chairman Osche reported there has been discussion with Alliance for Nonprofit Resources since they have the vehicles. She stated she believes there is a lot of potential opportunity, including the opportunity to try something to see if it works before going all in. Commissioner Geyer spoke about the advantage of doing this as a pilot and how it allows them to collect data and then use the data on the transportation project with the State. Commissioner Boozel stated he believes this is much needed for many things including employment, housing and human services.

## I. Treasurer

1. Chief Clerk Andrejchak announced that Diane Marburger will request approval of agreement with Aspira for doe license printers in the amount of \$247.50.

## J. Commissioners

- 1. Chief Clerk Scott Andrejchak will request approval of Ordinance 2 of 2018 \$5 Local Use Fee. Commissioner Geyer reported these funds will be statutorily used for roads and bridges only and that annual reports will be available to the public.
- 2. Chief Clerk Andrejchak will request approval of Resolution 2018-16 Authorizing the Butler County Department of Economic Development to Submit an Application for a Better Utilizing Investment to Leverage Development (BUILD) Grant in the amount of \$25,000,000. The County will commit \$5,000,000 to match funds of \$25,000,000 being applied for, coming in part by the Infrastructure Bank and the Regular Use Fee referenced on in Item J.1.
- 3. Chief Clerk Andrejchak will request approval of MOU with Alliance for Non-Profit Resources.
